SilkyEvCam®, an event-based vision camera from CenturyArks Co., Ltd. is a compact camera equipped with the Event-based Vision Sensor (EVS) which is an advanced image sensor that mimics the structure of the retina of the human eye. Unlike conventional frame cameras, the camera detects only luminance changes (brightness and darkness) and outputs pixel-by-pixel data at high speed along with pixel coordinates and time information. It is expected to be a solution to social issues such as the declining workforce, nursing care issues, and aging social infrastructures.

We invite you to join us in taking on the challenge of solving better social and problematic issues using the advanced technology of "event-based vision cameras" by demonstrating your free ideas, technological capabilities, and the results of your studies and research to date. #### ■ About Event-based Vision Camera

It does not capture motionless objects such as white lines, guardrails on the road and buildings, but it does capture automobiles and bicycles.

Lightning strikes just after the bird flies from lower right to upper left. You can clearly see the lightning running on the rail.

Even in the darkest places in the back and in intense light, the camera captures the running car.

An event-based vision camera is a camera that captures only the brightness of light (luminance change) and outputs the pixel coordinates and time information at high speed.

- The minimum time resolution is 1 µsec. It can be used for detecting abnormalities by detecting vibrations and for visual inspections on production lines. In sports, it can also capture the movement of a ball, racket, or athlete.
- With its wide dynamic range (>120dB), it can capture moving objects under the midsummer sun, which may cause halation, or, conversely, even in low illumination such as a warehouse. Since it only detects changes in brightness, it can also be used as a monitoring sensor for nursing and caregivers who want to protect their privacy.
- There is no motion blur (blurring of the subject).
- After capturing images, video can be created at different frame rates.
- Low data capacity and low power consumption allow for long-time shooting. Events that may appear at any time can also be captured in long shots.

#### ■Announcement of Results

The content results will be announced on the CenturyArks official website, and introduce it in our e-newsletter and social networking site.

The winners will be interviewed and the winners' work will be published in an article introducing the winning entries in an industry magazine in the first half of 2025.

### ■Entry and Submission Notes

- Submitted works must be the applicant's own original work, unpublished in Japan or abroad, not yet commercialized, and with no plans for commercialization in the future.
- Must refrain from submitting multiple entries to other contests.
- Only one entry per person or group will be accepted. Do not submit more than one entry per person or group.
- During the judging process, the entrant may be inquired about the submitted work.
- Subitted works that are offensive to public order and morals, or contain violent or sexual expressions will not be considered.
- If there is a possibility that the submitted work may infringe on the copyrights, portrait rights, trademark rights, design rights, or other rights held by a third party, it is the responsibility of the entrant to obtain the necessary permission and notify the Contest Office of such at the time of submission
- In the event that a third party files a lawsuit or other dispute over the submitted work, including infringement of rights, the entrant agrees to indemnify and hold the organizer harmless from any and all losses, damages, and expenses, including reasonable attorneys' fees, incurred by the applicant at his/her own expense and responsibility. The entrant agrees to indemnify and hold harmless the Sponsor from and against all losses, damages and expenses, including reasonable attorneys' fees.

- Entrants that are found to promote the activities of antisocial groups will be disqualified from the judging process. Even if it is discovered after the award announcement, the award will be revoked without notice.
- In the case of a minor winning an award, the winner will be confirmed separately in writing the consent of the person with parental authority. In the event that the consent of the person with parental authority is not obtained, the award may be revoked.
- Entrant may not claim any objection to the results of the judging, and the organizer is under no obligation to disclose the reasons for such an objection.
